# Total Nonfarm Employment Increased by 117,700 Jobs Year Over Year in July 2022 Arizona Unemployment remained at 3.3%


The Arizona seasonally adjusted unemployment rate remained at 3.3% from June 2022 to July 2022. The U.S. seasonally adjusted unemployment rate decreased from 3.6% in June 2022 to 3.5% in July 2022. Month over month, Arizona's seasonally adjusted labor force increased by 7,209 individuals or 0.2%. Year over year, the labor force increased by 57,286 individuals or 1.6%. Month over month, Arizona total nonfarm employment increased by 18,300 jobs or 0.6%. Year over year, total nonfarm employment increased by 117,700 jobs or 4.0%.

### **Month Over Month**

Arizona nonfarm employment increased by 18,300 jobs or 0.6% in July. Prior to the pandemic, nonfarm employment averaged a loss of 19,800 jobs in July (2010-2019). The government sector recorded a loss of 3,000 jobs in July, less than the pre-pandemic (2010-2019) average loss of 12,900 jobs. The private sector recorded a gain of 21,300 jobs in July, led by strong gains in Professional & Business Services and Education & Health Services. Prior to the pandemic (2010-2019), private sector employment averaged a loss of 6,900 jobs in July.

### **Year Over Year**





Arizona & U.S. Unemployment Rate Seasonally Adjusted




# Arizona & U.S. Nonfarm Employment Year-to-Year Percent Change




