Total Nonfarm Employment Increased by 64,800 Jobs Year Over Year in December 2023 Arizona Unemployment Remained at 4.3%

The Arizona seasonally adjusted (SA) unemployment rate remained at 4.3% in December 2023 from 4.3% in November 2023. The U.S. SA unemployment rate remained at 3.7% in December 2023 from 3.7% in November 2023.

Month over month, Arizona’s SA labor force increased by 6,295 individuals, or 0.2%. Year over year, the SA labor force increased by 97,642 individuals, or 2.7%.

Month over month, Arizona not-seasonally adjusted (NSA) total nonfarm employment increased by 8,100 jobs. Year over year, NSA total nonfarm employment increased by 64,800 jobs, or 2.0%. Arizona SA total nonfarm employment increased by 9,200 individuals, or 0.3%, month over month. Arizona’s SA total nonfarm employment of 3,189,300 in December 2023 is the highest in the state’s history.

Month Over Month

Arizona NSA nonfarm employment increased by 8,100 jobs in December. Prior to the pandemic (2010-2019), NSA nonfarm employment gained 5,600 jobs on average in December. The private sector recorded a gain of 10,200 jobs in December, led by gains in Financial Activities (3,800 jobs) and Trade, Transportation & Utilities (3,300 jobs). Prior to the pandemic (2010-2019), private sector employment averaged a gain of 9,700 jobs in December. The government sector¹ recorded a loss of 2,100 jobs in December, less than the pre-pandemic (2010-2019) average loss of 4,100 jobs. Employment losses in the government sector occurred primarily within State Government (-1,400 jobs).

- Financial Activities (3,800 jobs)
- Trade, Transportation & Utilities (3,300 jobs)
- Private Education & Health Services (2,500 jobs)
- Other Services (1,200 jobs)
- Manufacturing (100 jobs)

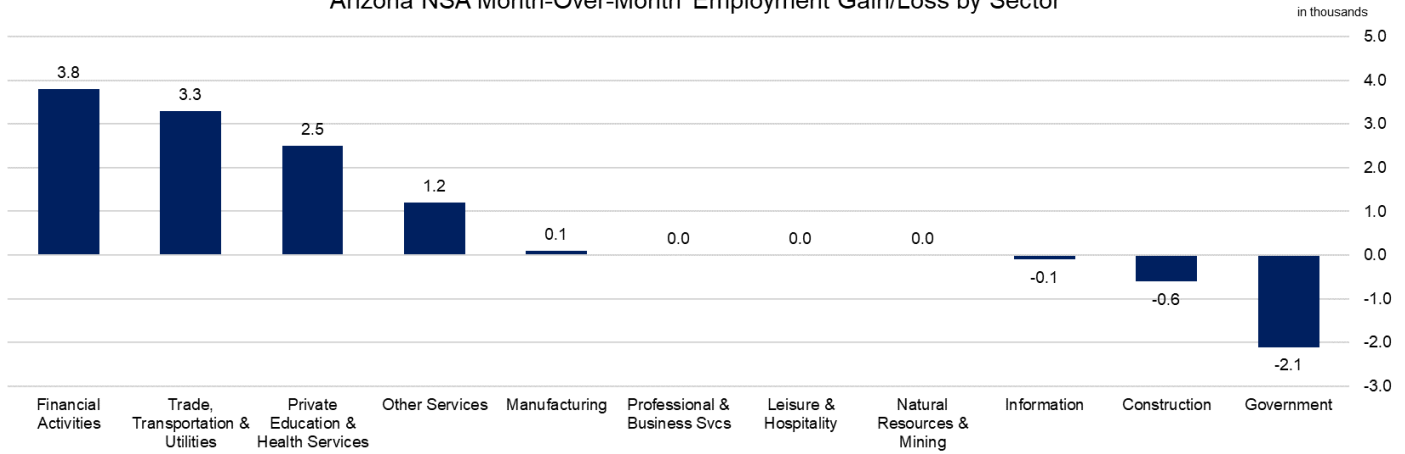

Year Over Year

Arizona NSA nonfarm employment increased by 64,800 jobs or 2.0% in December year over year. Private sector employment increased by 43,000 jobs year over year, while government employment increased by 21,800 jobs year over year.

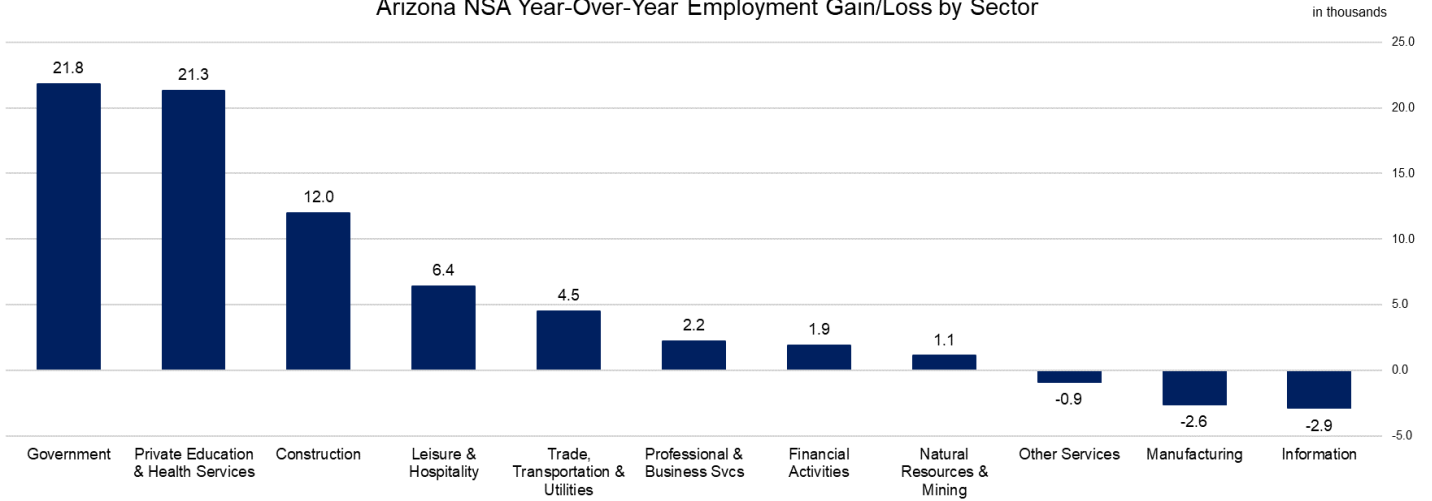

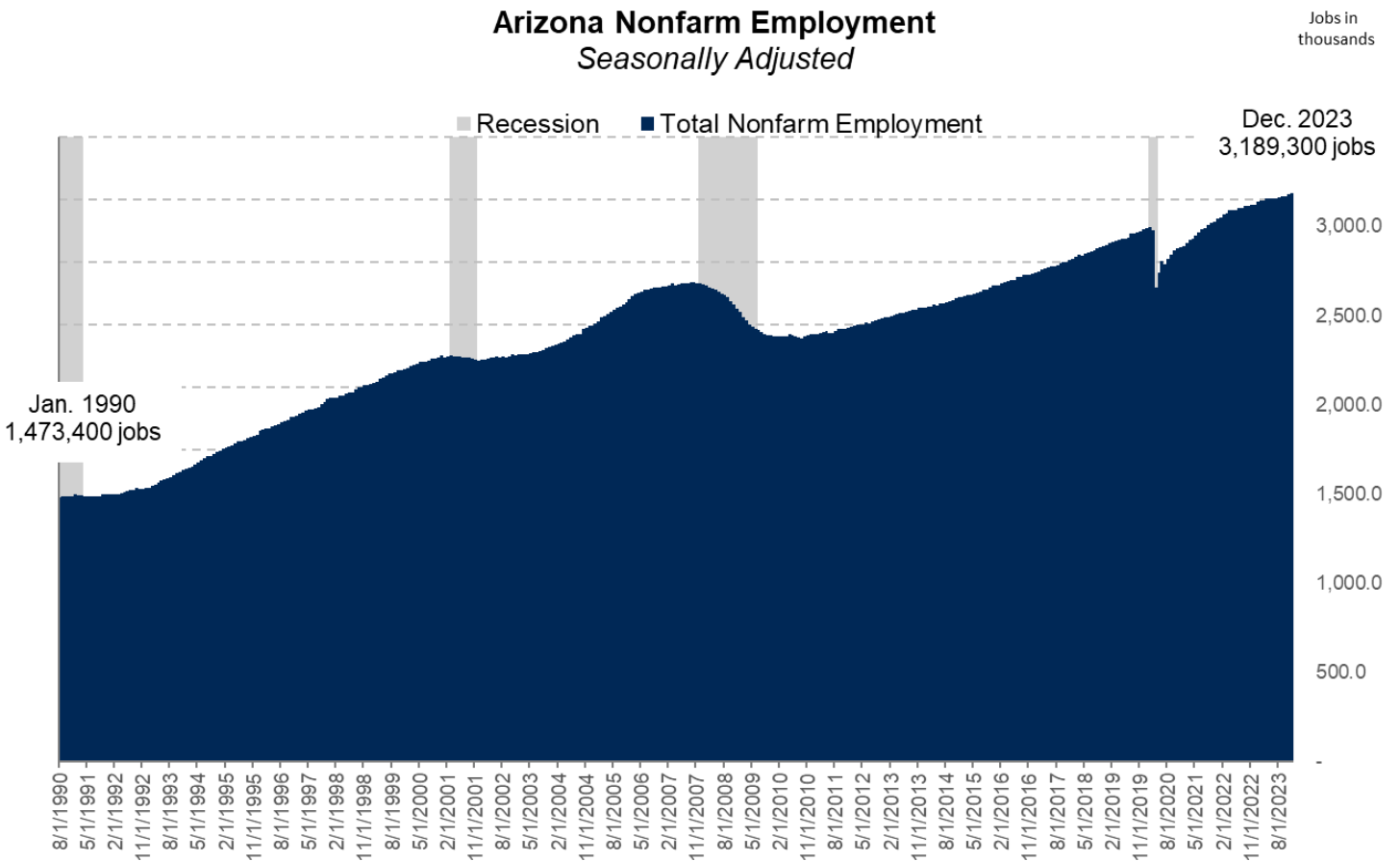

Arizona NSA Year-Over-Year Employment Gain/Loss by Sector



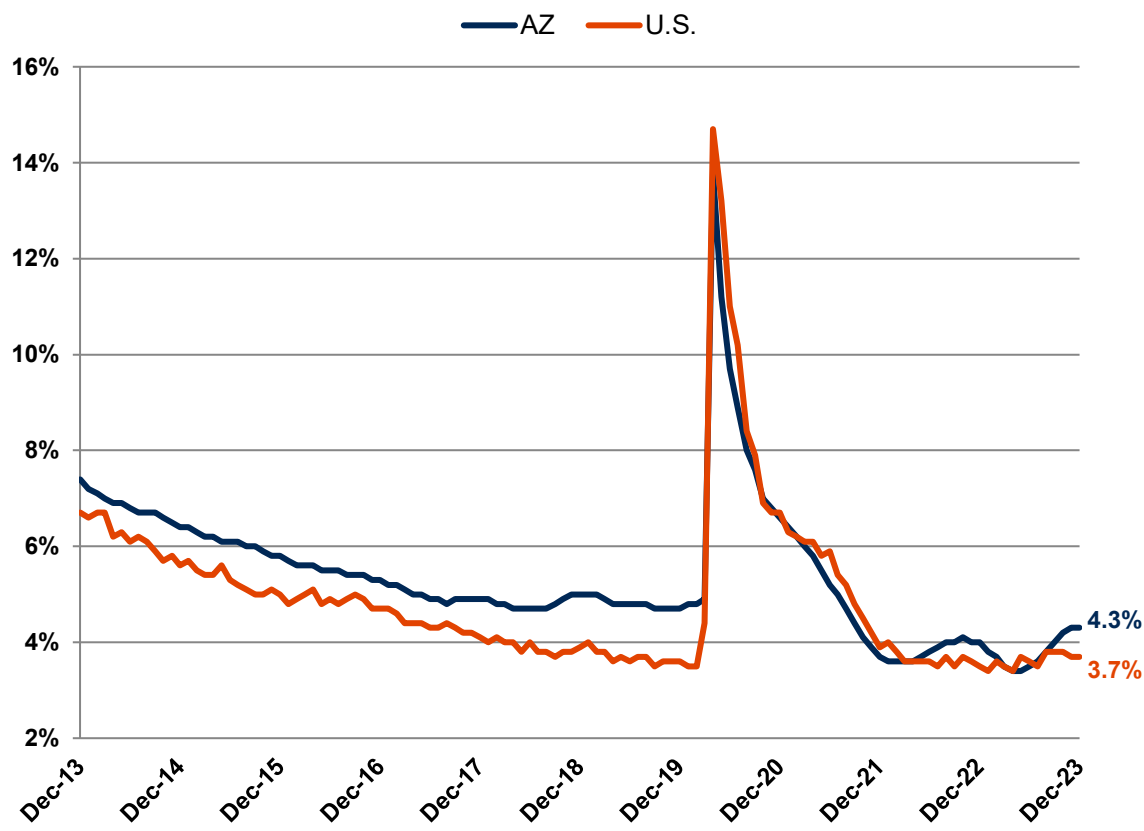

Arizona Nonfarm Employment Seasonally Adjusted

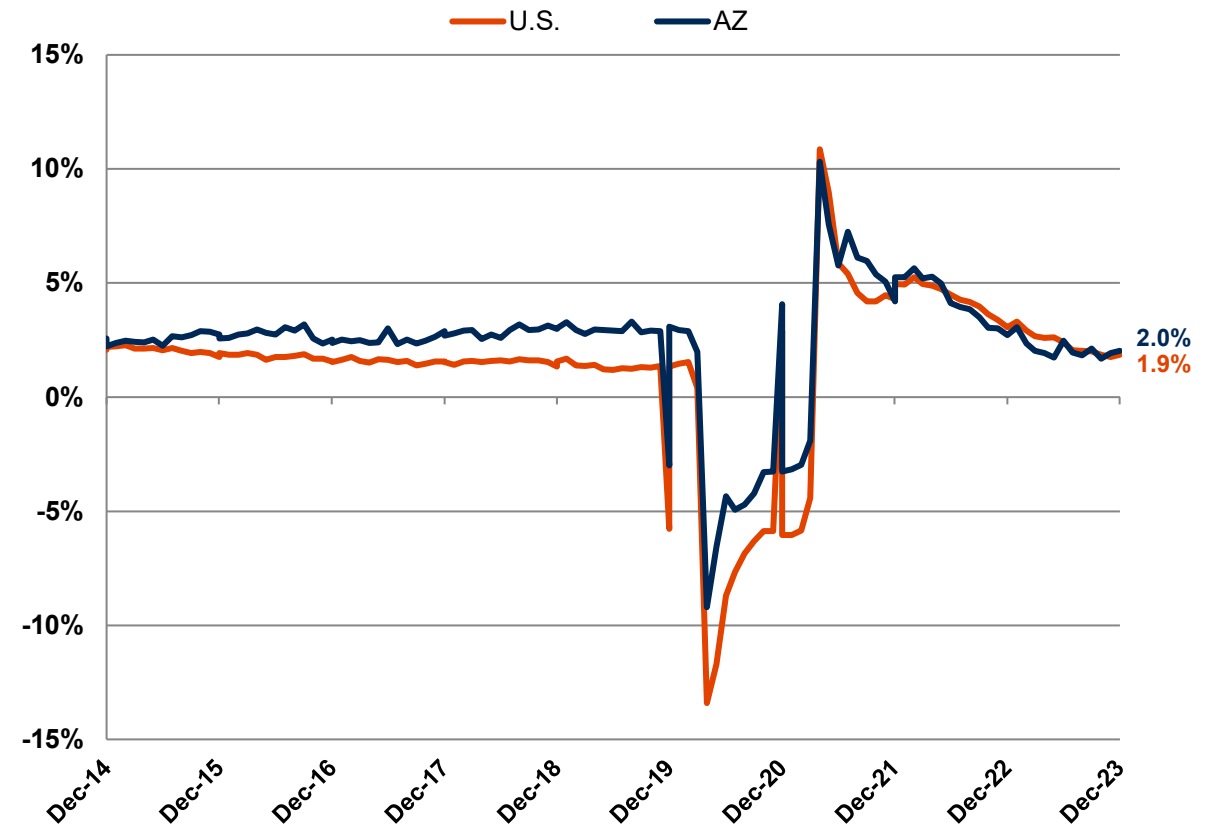

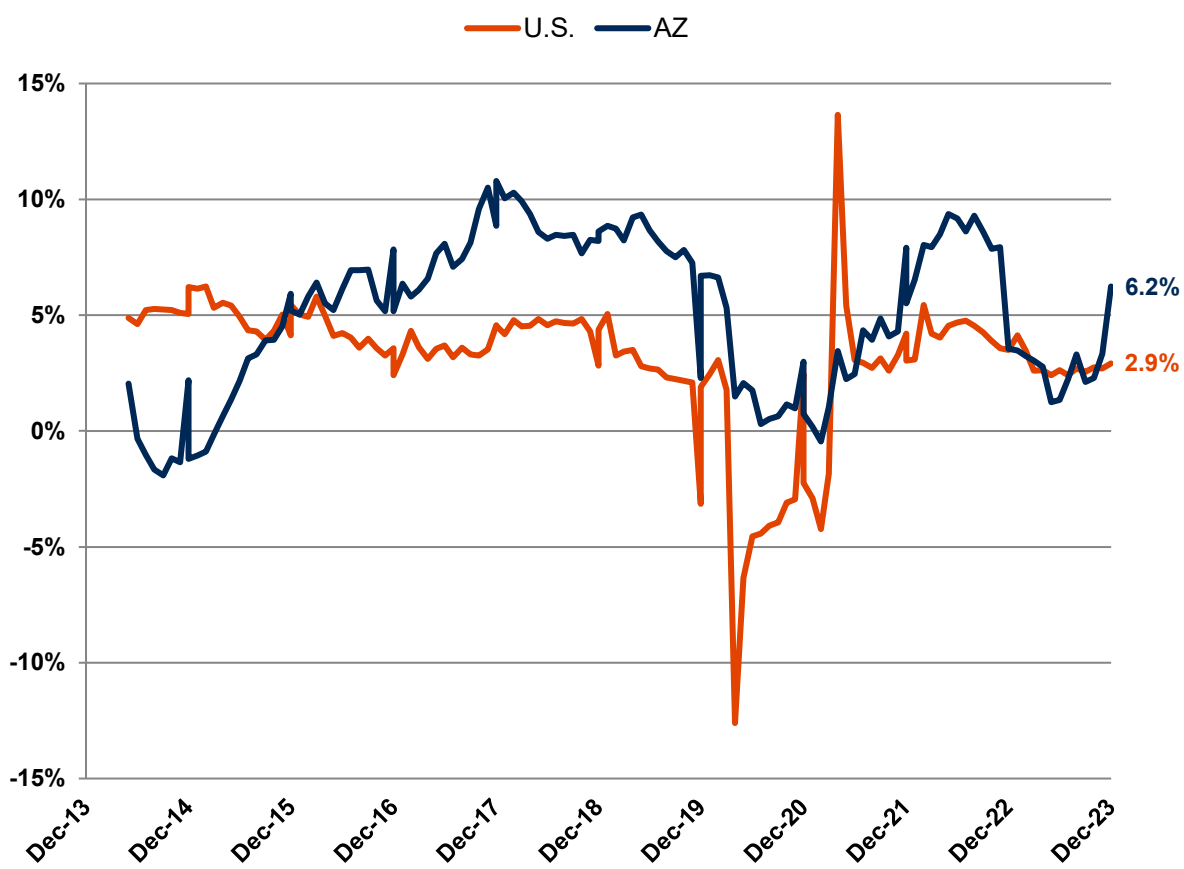
Arizona & U.S. Unemployment Rate
Seasonally Adjusted



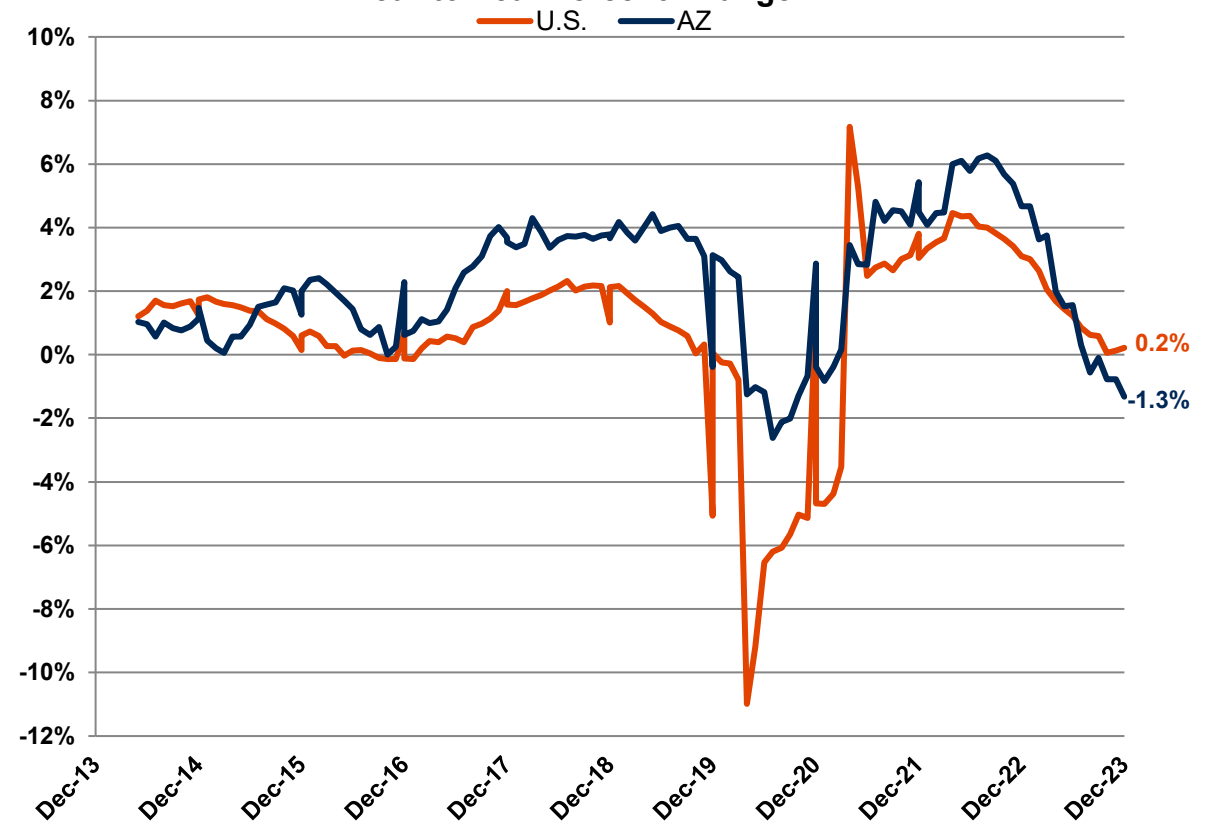
Arizona & U.S. Nonfarm Employment

Year-to-Year Percent Change



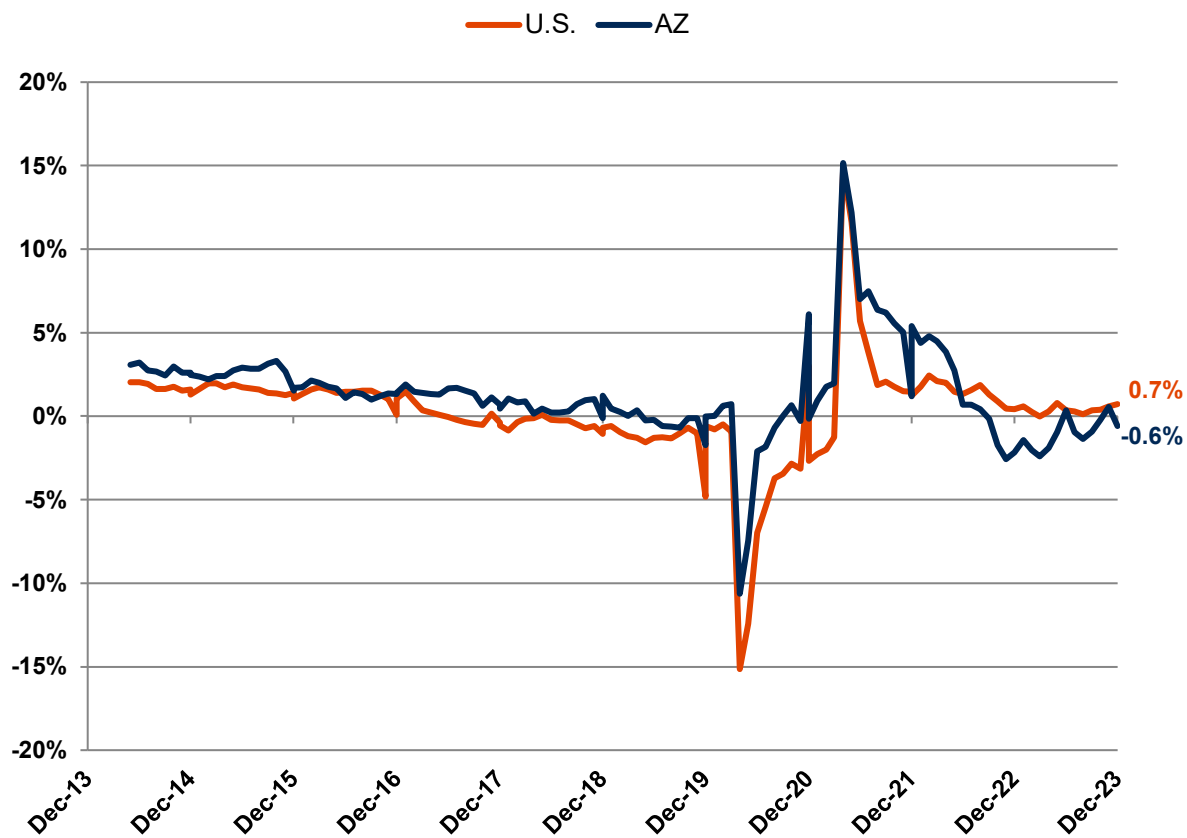
Arizona & U.S. Manufacturing Employment
Year-to-Year Percent Change



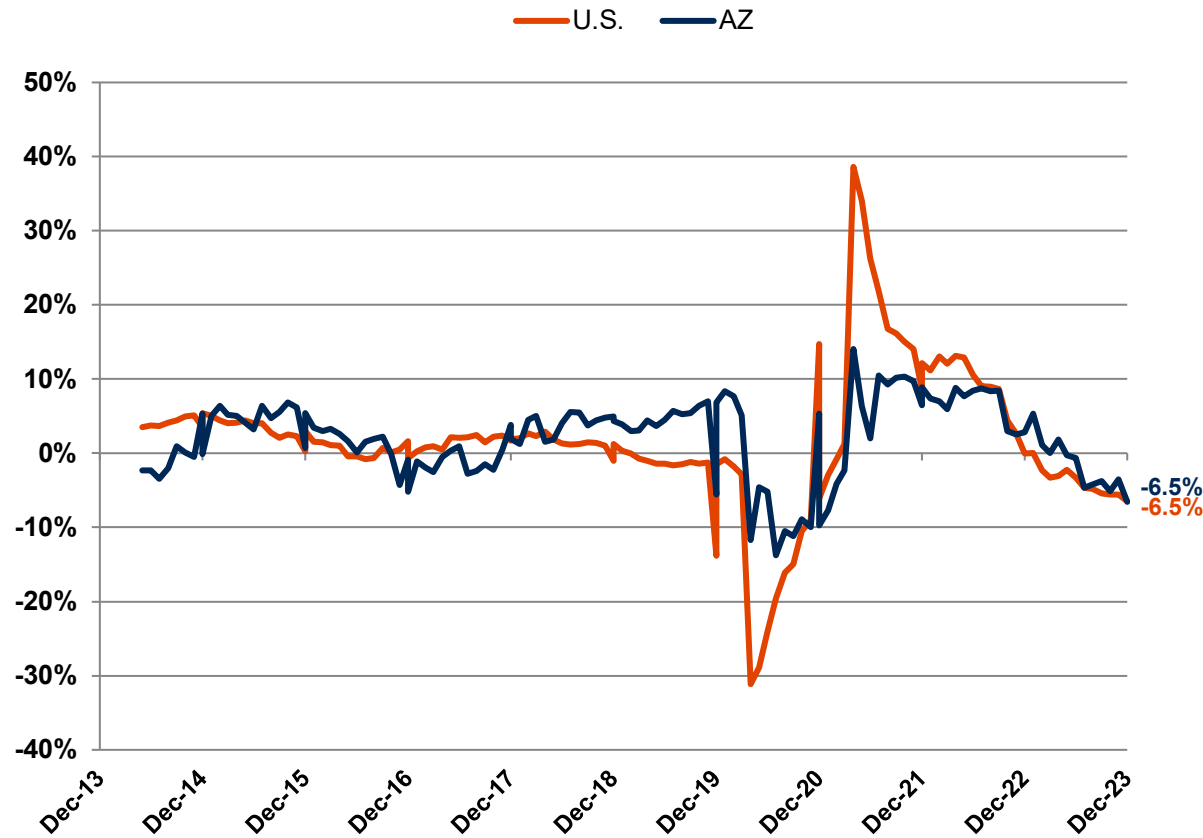

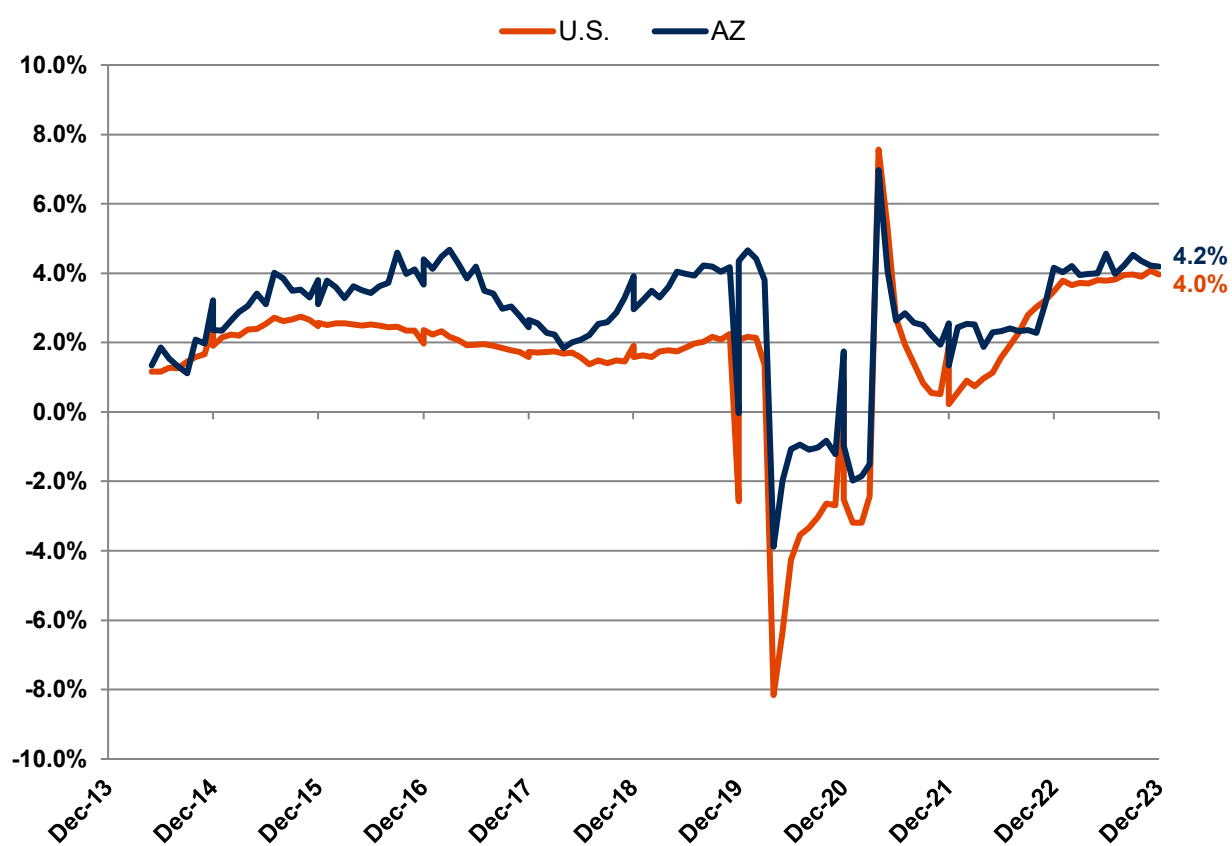
Arizona & U.S. Retail Trade
Year-to-Year Percent Change



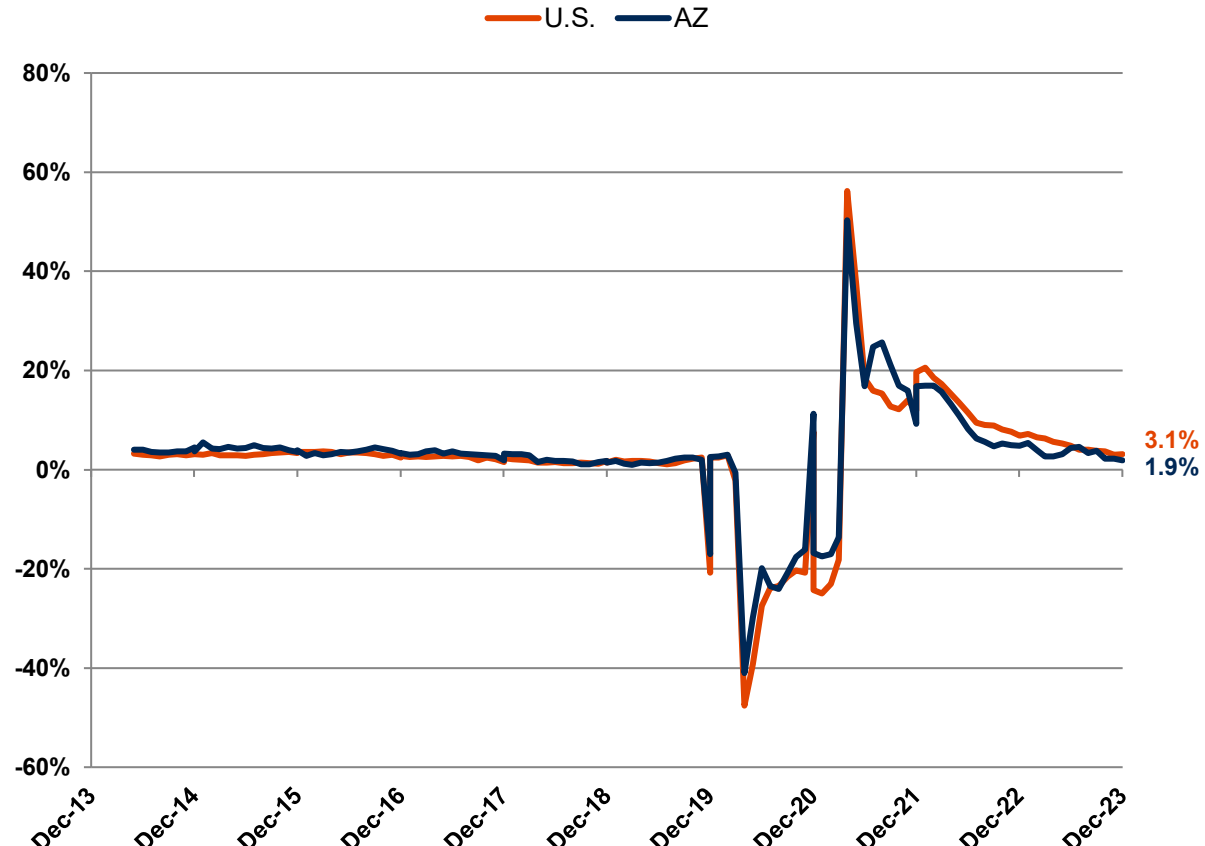
Arizona & U.S. Employment Services
